Health Guarantee



We guarantee that unless expressly noted otherwise, all our puppies have had all their current vaccinations/dewormed and completely vet checked, and free of all communicable diseases as is apparent to the eye, at the time of release to their new homes.

Within 3 days of adopting your puppy, you must take your pup to a reputable, licensed veterinarian for an exam. If the vet determines, within the three days, that the puppy is critically ill, or has died from injuries or illnesses likely to have been contracted on or before the date of the sale, you can choose one of the have the following options:

- Return the puppy for a full refund
- Return the puppy for a replacement pup of equal value
- Return the puppy and receive reimbursement for reasonable veterinary fees, not to exceed the original purchase price

We further guarantee the puppy named on this agreement to the original owner against debilitating or life-threatening hereditary/congenital conditions for **One Year** from DOB, or **One Year**, **Six Months** with the use of Life's Abundance food/supplements. (detailed on last page)

Claims

Claims on our Health Guarantee are subject to the following Conditions:

- You must provide a signed, written diagnosis of the genetic condition from a reputable licensed veterinarian, along with your original, signed Adoption Agreement contract. We reserve the right to have our own vet make or confirm a diagnosis under all circumstances.
- In the event of a confirmed claim, you have the same options as outlined above.
- Outside the three day window, Mountain Meadow Puppies is not responsible for any costs relating to the puppy
 after it leaves our premises, including, but not limited to, costs for vets, travel, etc in connection to the diagnosis
 of any genetic defects or other health conditions covered under our Health Guarantee.
- Under all circumstances, we reserve the right to refuse a refund if any of these conditions are not met, and any offers of partial, or full refund, reimbursement, or replacement will be issued only at our sole discretion.
- Puppies sold "as is", or with known genetic defects at the time of sale, and/or sold as "Pets", but used for show or breeding purposes, are not eligible for this Guarantee.

Our Health Guarantee does Not cover.

- This Health Guarantee does Not cover normal, treatable and/ or other non-life threatening conditions. (Fleas, parasites, ear mites, coccidia, etc.) Communicable diseases, specifically, parvo, Are Not Covered by our Health Guarantee.
- It is the owner's responsibility, to ensure precautions are taken against parvo, and other diseases, including keeping the puppy off the ground and away from public spaces, until it has had at least it's third vaccination and is well established into its new home.
- Mountain Meadow Puppies takes every precaution to keep a parvo and disease-free facility, and this
 responsibility is passed on to the new owner for the puppy named on this agreement at the time of sale.

Mountain Meadow Puppies ("us", "we", "ours") Adoption Terms

All sales are final, and there are No Cash Refunds given after the puppy has left our kennels. The buyer of the puppy, becomes fully liable for all costs associated with the puppy after it leaves our premises, including, but not limited to, vet bills, travel costs, food, medications, consequential or incidental damages, etc.

Any evidence of neglect and/ or abuse of the puppy will automatically void all warranties/guarantees, and may result in action on our part to remove dogs purchased from us, from such an environment, at the owner's expense. **Important:** If at any time, the buyer is no longer able or willing to care for the dog, it must be returned to us.

And finally, the buyer agrees that Mountain Meadow Puppies, its owners, any employees, and all their collective estate are released from all responsibility and liabilities for any damages, whether incidentally or consequentially caused by this dog, including, but not limited to, physical damage to property or any person(s).

Life's Abundance

- With the purchase of Life's Abundance food and/or nutritional supplements **on autoship**, this Health Guarantee is upgraded to another six months from the puppy's DOB, for a total of One Year, Six Months.
- In order to receive the extra six months credit, the buyer must sign up to receive Life's Abundance's food and/or supplements on autoship, and feed it regularly to the puppy, for the duration of the Health Guarantee, (1 year, 6 months from puppy's DOB)

Qualifications

- A) Have adequate food & water for your pup, & a warm, dry place for it to sleep.
- B) Have ample room for your pup to run and exercise.
- C) Are committed to the long-term quality care of your dog.
